**Sub: Revision of package rate of Joint Replacement
(with prosthesis)- Knee (Ortho 75 (a))**

**Ref: Order dated 16th August, 2017 of National
Pharmaceuticals Pricing Authority (NPPA), GoI**

All the network hospitals are informed that National Pharmaceuticals Pricing Authority (NPPA), Govt. of India vide Order at reference above has fixed and notified the ceiling prices of Orthopedic knee implants for knee replacement system w.e.f August 16, 2017. The copy of the said order is enclosed to this Circular.

In view of the above, Yeshasvini Trust is undertaking revision in the existing tariff of package code "Ortho 75(a)" regarding Joint Replacement (with prosthesis)-Knee. Presently the tariff rate for Joint Replacement (with prosthesis)-Knee procedure is as below:

Since Govt. of India vide GO at reference has revised the cost of implant in respect of Knee replacement, accordingly the cost of implant approved under the tariff package of Yeshasvini Scheme is being revised as below. However, the procedure cost of Joint Replacement (with prosthesis)-Knee procedure will remain the same.
